## Term I 2024/25 Tuition fee

Thank you for your continued support.

You will receive the invoice for the Term I tuition fee via a separate email. **The due date for the payment is Sunday, 11th August 2024.**

We continue to rely on the school fees to operate and your timely payment of the school fees is crucial for the quality education we provide. Below are the guidelines for making the payments:

- **Identification:**  
Please include your child's name, year group, and invoice number when making the payment. If you have more than one child, mentioning one child will suffice for identification.
- **Bank and Transfer Charges:**  
Please ensure you cover all the applicable bank charges to avoid any shortfall in the payment. In addition, please instruct your bank to remit the funds in UK pounds sterling (GBP) to avoid any exchange rate differences. Any shortfall in the fee payment will be notified by the Finance Department and such difference can be paid in cash at the finance office.
- **Local Currency Payments:**  
Nepalese parents without access to a foreign currency account can pay in Nepali Rupees. Prior approval from the Finance Department is required. For specific instructions, including bank details and applicable exchange rates, please contact the Finance Department.
- **Payment Confirmation and Queries:**

Late payment of tuition fees affects our operations and incur additional administrative costs. **The due date to clear the fees is before the start of the new term, which is Sunday, 11th August 2024.** As per our Financial Policy, we will be applying the penalty charge of GBP 2 per day to those who do not settle fees within the due date.
